## By Cleo Shambaugh Gervin ....

I am using the above theme-head quatation for a very definite reason—that is to try to convey to the many people of the Shambaugh clan the intense feeling that I have in regard to research and preservation of our family history and to hope that it may also stimulate dormant interest among all who may be reached by the News Letter. By all of us working together for the same cause we may yet get positive proof of family relationships and records of vital interest.

It is my privilege to tell you more of the family of George Jr., of Union, later Snyder County, Penn, George Ir was the son of George I, of Bucks County, Penn, As you know by now that all our records that have been handed down to us state that that George I arrived in Philadelphia on Sept. 9, 1749. Last summer I spent three weeks in research along this line most particularly. All records seemed to substantiate the above statement. I had hoped to see a bible and regord that are known to exist, which might prove our contention, but to date that has not been possible. The party who has the record was in another part of the state at the time I was in Sny. der County, Since coming home I have contacted this party and he told me of the old family bible also, which he had seen. He has promised me his co-operation in further search of records, but I presume that this war situation has deterred, for the present, any great amount of assistance along these lines, Mr. Thomas Shambach, of Middleburg, Snyder County, Pennsylvania, has the record, but he is very busy on work of the Pennsylvania Turnpike, which I am sure will play an important part in the de fense program. We will none of us have as much time for genealogy in the immediate future. I am sure.

Much that I will give you onthe family of George Jr., will be repetition, but with the addition of some new material will, I hope, tend to connect and perhaps clarify information that has been given before. Because I descend from George of Bucks County and also that I made a short stay in Snyder County last summer has earned for me the privilege of telling you more of this family. My great great grandfather was George Jr.

To begin with I will go back to Bucks County, Penn., for there we find the family of George I. I was able to visit several places last summer where different members of the family had lived. One old farm in Hilltown Township, Bucks County was purchased by George Shambach from the heirs of William Penn. This must have been a fine farm at one time for it is watered by several springs and creeks. At present it is somewhat run-down, but as farm help is hard to get I am sure that is the reason for it's present state. There are two very old houses on this farm. One is of log and the other of log and stone. A Dutch bake house and Dutch type spring house are evidence of the early German influence on building. It is a lovely old place and I was quite thrilled to be on one of the old home sites if not the first home of the Shambach family of our line.

George Jr., may have been born in Germany for if he were the oldest son, as we are led to believe, he must have been born in 1748. We have proof of the births of Daniel and Philip as well as Anna Marie and Dorothy, but of George there has been no record that has come to light thus far. If he was born in 1748 he was a bachelor of years before his marriage as stated to Miss Catherina Reinard of Montgomery Co.

George Jr., with his family lived for a number of years in Montgomery Co. Penn. Now Montgomery County was a part of Philadelphia Countyluntil 1784 and all records of Montgomery County prior to 1785 would be found in Philadelphia County. George Jr., however is thought to have married about 1789, so any records of his family should be found in Montgomery County. This is true of the birth of his second child for her paptismal record is found in the records of the Tohickon Reformed Church and also the records of her confirmation and that of her brother George III and their being received into the membership of the Falkner Swamp Church in 1806 and 1808 respectively. Whether this means that the family had changed places of residence or only churches between the date of the daughter Catherine's baptism in 1791 and confirmation in 1806 is a matter of conjecture, but it does prove that the family lived in Montgomery County as late as 1808.

According to my research I find the family of George Jr., in Union County, that part of which is now Snyder County, prior to 1815. George Jr purchased 300 acres of land a few miles north of Maddleburg from the agents of , or heirs of Wm Penn. The land then purchased was later divided into three farms, I am told. George Jr. died in 1815.

Of the children of George Jr: John, the eldest son married Catherine Walter: Catherine, married Ben Walter; George III married Catherine Weirich; Christian, married first Mary Walter, secondly Mrs Elizabeth Bechtel Bilger; a daughter Mary, perhaps Anna Maria, is said to have married a John Boyer and another daughter; Elizabeth is said to have married John Platte; Of the last two daughters no positive record has thus far been found, but I have found some data that seems to fit in with the two daughters and I will give it to you later.

In 1828 George III and his wife Catherine moved to Richland County, Ohio, where he built a lovely stone house. This house is standing today and is in splendid condition. There is also a large barn and Dutch oven on this farm, George III gave a corner of his farm to be used as a church, school and cemetery and in this cemetery are buried nearly all of the Shambaughs who lived in this section and there were many. The school was known as the Shambaugh school. George III was the ancestor of all of the Wabash, Indiana, Shambaughs.

In 1830 John, the eldest son of George Jr moved to Richland County, Ohio and

In 1830 John, the eldest son of George Jr moved to Richland County, Ohio and purchased a farm that is remembered as the Green Hill farm on the Black Fork creek. This is said to have been of the richest farm lands in Ohio. Green Hill was the site of the old Indian town of Greentown. It was the last home of the Delaware Indians. There is an old fort nearby known as Shambaugh's Fort. John Shambaugh raised his large family, many descendents of whom are still living in this section. He was my great grandfather.

Catherine Shambach Walter prior to this time had moved to Tonawanda County, New York with her husband and family. After the death of her husband, Catherine removed to Richland County, Ohio upon the invitation of her brother John, coming to Richland County in 1839. Catherine Shambach Walter was the grandmother of Henry Guthrie, the historian of the Richland County clan.

Christian Shambach remained in Snyder County, Penne where he reared a large family. His branch of the family are the clay members of this large family group of American Shambaughs that I know of that use the old spelling Shambach and so far as I know all of the members of the Snyder County group use that spelling yet. Several of Christian's children migrated further West. One, at least, lived near the other Shambachs in Richland County, Ohio and others moved to Indiana.
