ANOTHER SHAMBAUGH GOES TO HER REWARD. On March 1, 1942, shortly after midnight life left the body of Miss Mary Ann Elizabeth Rogers, better known as Miss Bettie Rogers, of near Reliance, Virginia. The body has been laid to rest in an old cenetery near her home in which others of her family, including her great grandmother Ann (Shambaugh) Hammock-Crampton had been laid. She had passed her 94th birthday on February 22. It was the privilege of all members of the editorial staff to have visited Miss Bettie and we found her a most unusual character, full of vitality far belying her years. THE SHAMBAUGH FAMILIES and thoir CONTRIBUTION to AMERICA

A sketch of the family of Daniel Shambach of Ponnsylvania and Virginia

A brave and valiant soldier was he who bere the colors of his companes-

"Daniel Shambach enlisted in Matthew Grier's Company on May 16,1777 and served as an ensign." -Penn. Archives 5th Serves V.P. 334

As a direct descendent of Daniel Shambach it has fallen to my let to prepare for you a more extended story of this early pioneer and his family. Unlike my two co-workers I do not have any traditional stories of the nativity of my ancestor and, indeed, until 1937 I had no definite proof of the name of his father. For some time I had been in correspondence with Joe H Shambaugh of Harveysburg, Chio who is a grandson of Joseph Shambaugh, one of the sons of Daniel. When I visited him in te summer of 1937 he advised me that his brother, Oscar Shambaugh, had a number of old letters in his possession that he believed would be interesting. Upon visiting this brother, then an invalid and since deceased, he gave me many old letters that were of priceless value to one hunting old family information, one of the letters being from my great-grandfather Jacob Shambaugh to his brother, Joseph, written upon the death of their father, Daniel and referring to his will. Proceeding to Winchester, and Front Royal, Virginia I found many documents on record of the Shambaugh family. Front Royal is the county seat of Warren County which, until 1835, was a part of Frederick County whose seat is Winchester. The will of Daniel Shambaugh was on file at Front Royal, and at Winchester we found a Superior Court Order concerning one George Shambach who had owned land in Hempshire County, originally a part of Virginia, but now in West Virginia. From the wording of this Court Order we have little doubt but that this George Shambach was the father of Daniel Shambach.

My grandfather. Thomas E. Shambaugh had a brother, Chas D Shambaugh who had written a short account of the Shambaugh ancestry in 1891 in which accounts he indicated that his father, Jacob Shambaugh was born in Pennsylvania in 1777 and that his grandfather had been a Revolutionary Soldier of French parentage. The Penn sylvania Archives reveal the further information that several Shambach's, including Daniel, Philip and probably two George's served in the Revolutionary War. Court records in Montgomery County, Pennsylvania establish the fact that Daniel Shambach owned land in that county and that he was a somein-law of Peter Hendricks. From the records of the old Geshenhoppen Church we find that Daniel Shambach was born in 1753 and from the letter, proviously referred to, passing between two of his sons we learn that he died in 1837.

Just when Daniel Shambach went to Virginia we do not know. What we do know is that he acquired title to land there in 1793 and that Philip and Ludwig also purchased land about the same time. We know, further, that George Shambach died about 1794 according to records on file at Rouney, West Virginia. We find, further, that there seems to have been a sister, Dorothy, wife of Jacob Snuder in the group that went to Virginia,

The facts given above concerning Daniel Shambach have all been checked on in the court house records and we believe them to be correct.

What about Daniel's family ? His will lists ten children, John, Jaceb, Joseph, Benjamin and Daniel. Mary, Margaret, Abigail, Rachel and Ann. Of these it is evident that all but three died and are buried in Virginia. When his will was filed in 1836 all were living but John and Benjamin.

John Shambaugh was probably the oldest son of Daniel and concerning his family we now have information secured by Mrs Gervin last summer when she discovered an old Bible owned formerly by Mrs Catherine Pingley, a daughter of John. In conversation with some of his descendents she also learned that he was quite a wealthy landowner and that he met his death by accident. From the records at Front Royal is appears that he married Rebecca Kendricks, December 24, 1804. He purchased some of his land from J. Kendricks in 1813 and sold land to Abe Spengler in 1820, so has decease must have occurred after the latter date. The Bible referred to gives his family as follows, John, born December 6, 1806-Miza Ann, August 21, 1807-Catherine, October 15, 1809-Samuel, May 1811-Joseph, October 9, 1812-Daniel, March 9 1814-Mary Jane, July 6, 1816- and Rebeccah, Feb. 8, 1818. Five of these children are mentioned in the settlement of the estate of Daniel Shembaugh with his son Jacob in 1841, naming Jonas H Shambaugh as their guardian, these being " Catherine Shambaugh, Win Holmes wife, Chas D Shambaugh, guardian for Matilda M Shambaugh, Watson Peery's wife and Dan C Shambaugh. * This would seem to indicate that the others were deceased or not married at that time. Catherine matried David Fingley, June 20, 1844. She died March 25, 1870. Her Bible is in possession of Mrs Ed Pingley, R#2, Strasburg, Va. Eliza Ann is identified as the wife of Wn Holmes, Mary Jane was the wife of Chas D Shambaugh and she had died in 1839 leaving an infant daughter, Matilda M. Rebecca was the wife of Watson Feery whom she married October 29, 1835. She was the mother of Eliza Jane who married S. Hammock, of Chas Milton who married Mary Kline, of Catherine who died at the age of 14 and of Genevieve (Jemervey) who married S B Kline, three of whose children hive in Winchester at this time. Daniel C., the youn gest son married Mary Ann Kline, February 24, 1840

Jacob, My immediate ancestor, was born in Pennsylvania April 19, 1777 and was quite a lad when the family landed in Virginia. Upon his marriage to Mary Barrow, daughter of Whi Barrow, and granddaughter of the immigrant, Thomas Barrow of England, he seems to have settled down somewhere near his father's plantation, in . fact, in 1821 he seems to have bought some land from his father. While we have not as yet traced the land holdings of the various Shambaugh families in Frederick and Warren counties it would not seem amiss to suggest that the land he owned was the same as that where the Shambaugh burying lot is located near Reliance, in which lot Jacob's bones, together with those of his sister, Ann, two of his children and two grandchildren lie. Chas D Shambaugh was his oldest son being born Dec. 31, 1812, marrying- first-Mary Jane Shambaugh on Feb. 5, 1835 and second, Sarah E. Guyer on June 24, 1847. Thomas Ephraim Shambaugh, my grandfather, was born April 4, 1822 and died Sept, 24, 1867. He was married Nov. 30, 1843 to his second cousin, Barbara Ann Larrick. One daughter, Sarah Ann Shambaugh married Nimrod Showalter in 1839. Another daughter, Mazy Jane, grew to old age in spinsterhood, living with my grandparents and I can still remember " Aunt Jane" always found a cookie-jar for me when we came into town from our home in the country. Jacob died January 3, 1855. His daughter and her husband had previously moved to Indiana. Following his death the remainder of his family with his widow packed up and moved west, evidently heading either for Missouri or for southwestern Iowa where other relatives had previously gone. They entered the state at Dubuque and while sojousing there made contact with land age is who sold them land in Fayette County, acquiring property southwest of Arlington, then, Brush Creek August 25, 1855.
